Website Privacy Policies

This Privacy Policy describes Our policies and procedures on the collection, use and disclosure of Your information when You use the Service and tells You about Your privacy rights and how the law protects You. We use Your Personal data to provide and improve the Service. By using the Service, You agree to the collection and use of information in accordance with this Privacy Policy.

Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

Definitions

For the purposes of this Privacy Policy:

- <u>Company:</u> (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to NovaEMDR PLLC, 12644 Chapel Road #283 Clifton, VA 20124-9998 USA.
- <u>Cookies:</u> are small files that are placed on Your computer, mobile device or any other device by a website, containing the details of Your browsing history on that website among its many uses.
- <u>Device:</u> means any device that can access the Service such as a computer, a cellphone or a digital tablet.
- **Personal Data** is any information that relates to an identified or identifiable individual.
- Service Provider means any natural or legal person who processes the data on behalf of the Company. Sharing Your Personal Data

Use is limited to providing services, providing You with information, and then is deleted or stored in ways that are HIPAA Compliant.

<u>Usage Data</u> is collected automatically when using the Service. Usage Data may include information such as Your Device's Internet Protocol address (e.g. IP address), browser type, browser version, the pages of our Service that You visit, the time and date of Your visit, the time spent on those pages, unique device identifiers and other diagnostic data.

 - o Purpose: These Cookies identify if users have accepted the use of cookies on the Website.
- Functionality Cookies
 - o Type: Persistent Cookies
 - o Administered by: Us
 - o Purpose: These Cookies allow us to remember choices You make when You use the Website, such as remembering your login details or language preference. The purpose of these Cookies is to provide You with a more personal experience and to avoid You having to re-enter your preferences every time You use the Website.
